About the Mental Health Shared Care Program (MHSC)

The MHSC aims to assist individuals with complex and chronic mental health issues by supporting them to increase their capacity to manage their physical and mental health and avoid hospital admissions. A key element of the service is the facilitation on integration between the services involved in a person's care including their GP.

Services within this program are provided at no cost and clients must be on a low income and/or must be unable to afford or access a Private Practitioner. Clients can be seen for approximately 3 months.

Clients must have a diagnosis of a complex and chronic Mental Health disorder including schizophrenia and other psychotic disorders, severe anxiety and depression and/ personality disorders, or be at risk of developing one of these diagnoses. You must also be over 18 years of age.

GETTING SUPPORT

Referral Process:

People can access the service **by visiting their GP for a referral.**

A Mental Health Treatment Plan (item 2715/2717) is required to be completed by the referring General Practitioner.

Who is not eligible:

This service is **not designed for people in acute crisis or at risk of suicide** (in this case, emergency procedures need to be implemented including contacting Rural & Remote Mental Health on 131465). This service is also not suitable for people who are being case managed by State Government mental health services or who are receiving mental health services from another provider.

OUR MENTAL HEALTH CLINICIANS

Summit Health employs a variety of Clinicians with varying backgrounds and qualifications.

Clinicians currently providing services include:

- Mental Health Social Workers
- Mental Health Nurses
- Psychologists

Summit Health's Clinicians have extensive counselling experience working with clients with various mental health concerns. They are trained in a variety of therapeutic interventions/approaches (including Cognitive Behavioural Therapy (CBT), Relaxation Strategies, Motivational Interviewing, Narrative Therapy & Interpersonal Therapy).

- Services operate from 9-5pm Monday to Friday (excluding public holidays)
- Counselling sessions are typically approx. 50 minutes in duration
