CEO REPORT

OVERVIEW

It has been another successful year for Summit Health. Key achievements over the 12 months include:

- EDcare and GPcare's contribution to immediate bushfire needs and the subsequent mental health support offered at Lobethal and Parndana.
- Surviving COVID-19 impact.
- Summit Health Centre's occupancy levels and new services attracted to the region.
- Engaging Dr Emma Manifold as our Medical Director.
- The growth in the range of our mental health services.
- Expansion of the Hopper Ant Allergy Clinic to Mt Barker.



A major task looking forward will be working alongside Barossa Hills Fleurieu Local Health Network (BHFLHN) on the design and construction of the new Emergency Department at the Mount Barker Hospital.

HIGHLIGHTS OF THE YEAR

A key initiative this year was the rollout of the Board's new Strategic Plan for the next three years which focuses on growing our engagement with local GPs and Practices and expanding the range of services we offer.

The Strategic Plan builds on our ever present commitment to quality across the organisation.

The Summit Health Centre continues to provide a purpose designed facility for specialist and allied health services to locate and grow their businesses, providing unique flexibility and an extensive support network.

I am pleased to report that we have ended the Financial Year in a sound position, and made a strong contribution to our financial reserves. More details on our financial performance can be found in the Finance Committee's Report on page 16.

A highlight of the year saw the opening of the Summit Café social enterprise in September. This was a unique collaboration with the disability support organisation Community Bridging Services Inc.

To end the year on a high note, we saw the finalisation of ongoing work to establish the first satellite clinic on mainland Australia for the Hopper Ant Allergy.

The Hopper Ant (Jack Jumper Ant) is endemic to the Adelaide Hills and it made sense to establish the service closer to where people live. Dr Adriana Le, a clinical immunologist/allergist who practices in the Centre and at the RAH oversees the desensitisation treatment.

CHALLENGES

This year has presented challenges which we chose to see as opportunities to be seized and used to better position our organisation for the future. COVID-19 and the bushfires in our area presented the biggest of these challenges and had the impact of breaking much of the rhythm that had been developed at Summit Health and elsewhere.

Our immediate response to the situation was to support increased mental health services and work with relevant funders and stakeholders to deliver an ongoing service.

The current situation with GPEx and the pending takeover by RACGP / ACRRM of GP training program funding next year continues to be of concern and remains a work-in-progress for us in partnership with other like-minded organisations.

The car-park at the Summit Health Centre is now full to overflowing, which may have a significant impact on some stakeholders. Watch this space!

We did have plans to throw a big party to celebrate our 25th birthday in late 2020, needless to say, COVID-19 has required a rethink which is disappointing. We look forward to the formal celebration taking place in 2021.

COVID-19

The pandemic has had a major impact on all General Practices and Health Providers. It has also been a catalyst for increased innovation, and potentially highlighted areas in each of our businesses where we could improve. Clearly the end point is not yet in sight, however, the effective management of the virus in South Australia is something we should all be proud of.

The excellent results outlined in this report would not be possible without the hard work and commitment of our highly valued staff and contractors, together with ongoing support from our tenants.

I would also like to thank our funding bodies; Country SA PHN for their support across a range of programs – but particularly mental health, BHFLHN and our banking partner Commonwealth Bank.

My special thanks for the support of the Board and my Management Team; Penny Heinrich (General Manager), Jo Teakle (Clinical Services Manager) and Bruce Stocks (Mental Health Unit Manager) without whose support none of this would be possible.

In addition to these external challenges, we have also invested significant monies in improving our internal systems, a process that will continue into next financial year.



As always, we continue to reinvest the vast majority of our funds back into health service delivery and member services.

SERVICE OVERVIEW

The Summit Health Mental Health Service has had a complex year providing individual counselling and therapy services to many types of consumers in a range of regional settings.



Our services, funded by the Federal Government and delivered locally, contribute to the community in what is called a Stepped Care Model of Mental Health Services. We tend to provide services in the mid-range need of mental health problems.

Whilst we don't provide acute, high-need services such as our colleagues in Emergency Hospital Care and State Funded Local Health Network Community Mental Health Services, we support these services by providing step-down counselling and therapy services as people leave acute and high-need situations in our Shared Care, Clinical Care and Coordination Programs.

Another program, the Psychological Therapies Service, is designed for adults, youth and children who need information, linkages, counselling and therapy for conditions common to most people; support around grief, depression, anxiety, relationship problems, alcohol and drug issues and the like.

We provide these three programs across the Adelaide Hills at Mt Barker, Lobethal and Stirling, on the Fleurieu at Victor Harbor, Yankalilla, Goolwa and Strathalbyn and Kingscote, Kangaroo Island.

BUSHFIRE RECOVERY WORK

In addition to normal service provisions, from early January this year we have engaged in Bushfire Recovery Counselling and Therapy. Country SA PHN has funded the service so that we have been able to have clinicians dedicated to this work at Lobethal and Parndana.

OVERVIEW

GPcare General Practice is nearing completion of a successful and extraordinary year of operation since commencing in November 2014 with the opening of the Summit Health Centre.



Dr Emma Manifold was appointed as Summit Health Medical Director in February 2020; and has provided extensive clinical experience and guidance to GPcare; particularly throughout the COVID-19 pandemic.



GPcare provided an essential overflow service during the catastrophic Cudlee Creek bushfires in December 2019; remaining open throughout the evening to support the EDcare service and MBDSMH Emergency Department.

The impact of the COVID-19 pandemic saw the introduction of MBS telehealth item numbers allowing for a new way of consulting for GPs and patients.

GPcare established a successful outdoor respiratory assessment area and ran outdoor flu vaccination clinics.

GPcare is supported by an experienced and dedicated core group of GPs; including GP Registrars from GPEx and sessional GPs, equating to 7.7 clinical FTE.

We welcomed the following GPs:

- Dr Babak Taghavi Ardebili joined GPcare in September 2019 after relocating to Adelaide from Port Pirie; where he spent eight years working as a rural GP.
- Dr Katya Speight commenced with GPcare in September 2019. Dr Speight has been practicing as a GP in the Adelaide Hills for many years.
- In March 2020 we welcomed Dr David Mills, who is a Rural Generalist and former Director of the Adelaide Rural Clinical School at the University of Adelaide.
- Dr Dan Dwyer, GP Obstetrician, commenced with GPcare in April 2020 and has settled in well supporting Dr Cath Love with her antenatal workload and also working on the EDcare roster.
- GP Registrar Dr Naif Saigol achieved fellowship with the RACGP in August 2019 and has continued on with GPcare.
- Dr Cassie Gibbs has embraced the role as GP Supervisor for our GP registrars.

We farewelled Dr Graham Hughes and Dr Mark Crawford during 2020. We thank them for their significant contribution to GPcare throughout the last six years.

GPcare is also supported by a dedicated and experienced team of nursing and reception staff.

GPcare continues to support medical workforce development and are hosting two 5th year medical students (Rebecca Langhans and Ben Goetze from the University of Adelaide), undertaking their rural placement in Mt Barker during 2020.

Our 6-8 week placements for 3rd year nursing students from Flinders University continue to provide a valuable General Practice experience for our future nursing workforce.

OVERVIEW

EDcare has seen another successful year, in providing a quality 24 hour emergency service to our region.

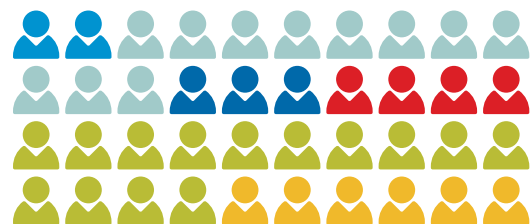
EDcare has faced many challenges during the year with the Cudlee Creek bushfire; COVID-19 pandemic; and the ever increasing acuity.



Highlights have included increased educational opportunities for Medical and Nursing staff and South Australian Ambulance Service.

This year, patients seen by medical staff totalled 15,328, only a slight increase of 0.03% on the previous year.

Increasing patient acuity and lengths of stay can account for the minimal change in patient numbers.

CUDLEE CREEK BUSHFIRE

EDcare provided an essential frontline service during the catastrophic Cudlee Creek bushfire emergency in December 2019; with varied presentations including life threatening burns, smoke inhalation and shock.

A total of six Doctors were on duty during the evening, with many Doctors making themselves available over the weekend to ensure the department was staffed appropriately if required.

As the hospital became rapidly overloaded throughout the evening; the Summit Health Centre remained open well into the night, with GPcare GPs assisting with overflow from the emergency department.

All staff are to be commended for their dedication throughout this catastrophic event.

COVID-19 PANDEMIC

In close consultation with SA Health, EDcare was asked to plan for a two stream ED model.

The initial plan was to separate ED into two departments - respiratory and non-respiratory; essentially doubling EDcare medical and administration staffing requirements.

Thankfully, the need did not arise and EDcare maintained close consultation with SA Health and SA Ambulance Service to ensure clinically safe and prompt management of patients throughout the COVID-19 period.



Dr Peter Stuart engaged with the hospital to ensure all infection control needs were addressed within the Emergency Department; to ensure proper procedures were followed in regards to aerosolisation in the use of O₂, intubation and other gases/medications and the effective use of available PPE.

This was replicated across the region at the request of Gawler Health Service, with Dr Stuart visiting GPinc to assist and advise their clinical team on the same.

EDcare remains on high alert and ready to respond if the need presents itself once again.

EDUCATION

EDcare Emergency Education sessions are facilitated by EDcare Clinical Director, Dr Peter Stuart; and are available at no cost for all EDcare doctors to attend.

Monthly Mortality & Morbidity (M&Ms) meetings were scheduled during the first half of the year.

These meetings provide valuable learning opportunities for EDcare doctors, hospital nurses and SA Ambulance Service to review challenging cases that present to EDcare. Emergency Education sessions have been well attended and have included:

- ultrasound workshops
- emergency airway and ventilation
- pacing and cardiac arrhythmias
- paediatric resuscitation
- procedural sedation
- fracture management

EDcare has continued to deliver education sessions throughout the year as the COVID-19 pandemic restrictions have allowed.

Planning and development for the new build of the Emergency Department is underway, with the aim of being in residence 2022 - watch this space!

In the meantime, EDcare continues to meet regularly with Barossa Hills Fleurieu Local Health Network, closely monitoring trigger points to ensure the department is staffed safely, and as cost effectively as possible; ensuring available space is optimised for best patient outcomes.

INTEGRATED WELLBEING SERVICE

The Integrated Wellbeing Service (IWS) is funded by Country SA PHN via our FocusOne Health partners.

Summit Health contract KI Medical Clinic to deliver care coordination under the program, which has a focus on chronic disease management and the provision of allied health services on Kangaroo Island.

It has been an extra challenging year for the Kangaroo Island community, and yet the adaptable team at KI Medical have continued to provide telehealth options and referral to the IWS Allied Health services where possible.

Education was provided for local Practice Nurses and the community also participated in diabetes updates and a Health and Wellbeing Forum in Kingscote in November.

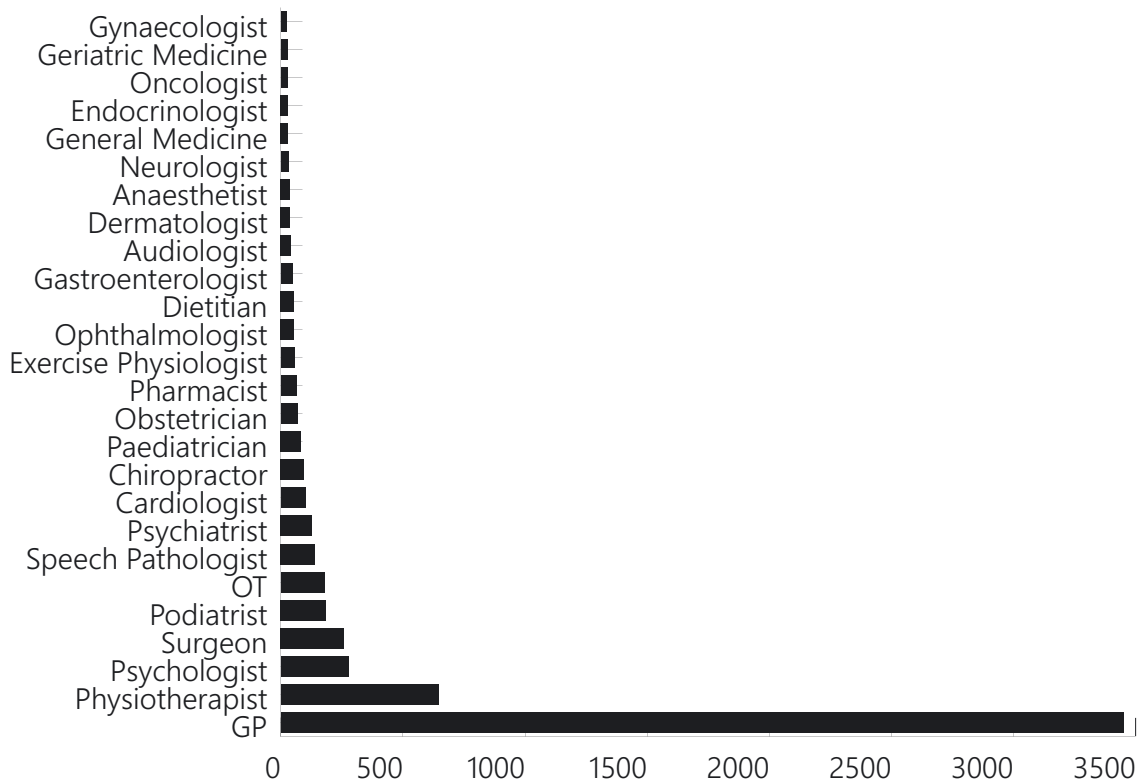


HEALTH PROVIDER REGISTRY

The Health Provider Registry (HPRy) enables a vital connection with health providers, general practices and health services across South Australia.

Summit Health maintain the HPRy database which supports the transfer of patient information such as discharge summaries and specialist referrals. The database contains 6,248 practitioners and 2,532 practice types. 65% of providers were validated in the 2019 validation process, which is conducted annually.

In the final quarter of 2019-20, regular discussions with SA Health around the future move to secure messaging have been undertaken. The emergence of COVID-19 emphasised the importance of these validated communication channels to ensure that there could be no gap in important patient health information. Communication preferences are positively moving in the direction of electronic mechanisms including secure email and messaging.

AFTER HOURS INNOVATION PROJECT

The After Hours Innovation Project (AHIP) has been commissioned to Summit Health via the Country SA Primary Health Network.

This project is designed to support eight Hills Residential Aged Care Facilities (RACFs) access after hours medical support when the regular General Practitioner is not available.

The service provides telehealth medical assessments using the SA Health endorsed platform Cisco Jabber. Staff within a RACF have access to Clinical Pathways to support their clinical decision making. These tools provide a quick reference guide to assist in the clinical management of the resident, which negates or minimises the need for transfer to hospital.

If the Clinical Pathway leads to the activation of the Hospital Avoidance Pathway, Residential Aged Care staff simply follow the directions whilst support is provided by SAAS and the Triage Nurse at EDcare until the Medical Officer is available for a Cisco Jabber Telehealth Consult.

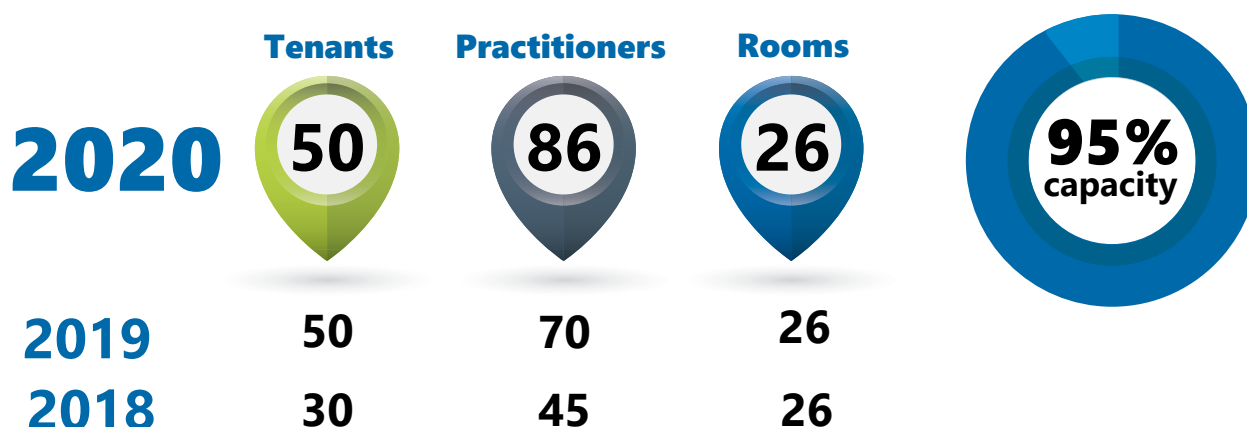

OVERVIEW

COVID-19 IMPACT

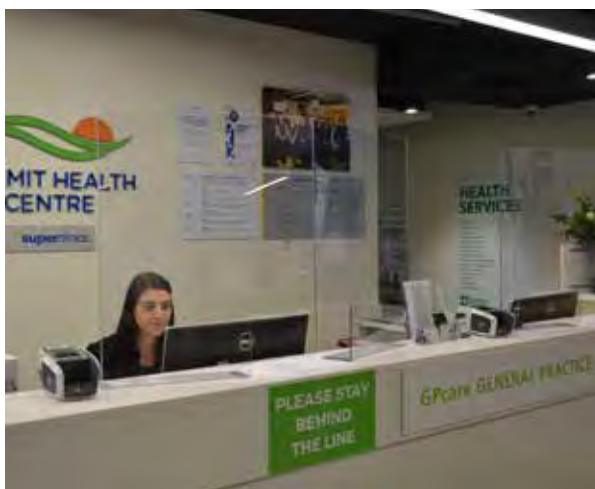
Feedback from tenants throughout the COVID-19 period was overwhelmingly positive regarding the COVID-19 safety measures put in place around the Centre.



Rent relief was offered to all tenants with less than 50% taking up the offer for the April to June quarter.

COVID-19 safety measures around the Centre have included:

- Staffed temperature screening at front entrance, 6 days a week
- Decals (ticks and crosses) on waiting room chairs to promote social distancing
- Installation of protective screens on all reception counters
- Floor signage indicating where visitors and patients should stand
- Extra sanitiser dispensers installed in waiting room areas
- Cleaning procedures implemented for common touch points around the Centre



ENVIRONMENTAL BENEFITS

Summit Health has continued to work with Trees for Life, planting 385 seedlings in winter. The soil has improved dramatically with significant mulching over the past year.

The Solar Panels continue to provide environmental benefits, with the equivalent of over 3,000 trees planted, and over 100,000kg of CO2 emissions saved.

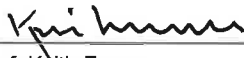

Note 1: Summary of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act of South Australia. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

(b) Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

(c) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(d) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

(f) Leases

Leases of PPE, where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the association, are classified as finance leases.

Finance leases are capitalised by recording an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments, including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for that period.

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term. Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the period in which they are incurred.

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the assets and liabilities statement are shown inclusive of GST.

(h) Trade and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period, which remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.
